# **Meeting Topics**

#### 1. SHARE / ECHO Presentation

- a. Helen Kelley, Diana T. Myers and Associates, Inc. presented on the SHARE and ECHO housing options.
  - i. SHARED Housing was defined as involving the voluntary matching of a home host (someone with at least one extra bedroom) and a home sharer (someone willing to live in someone else's home). An older adult can be either the home host or home sharer. The home sharer has his/her own bedroom and both parties share living, dining and kitchen areas. Either person can provide services to help the other (for example: assistance with laundry or cooking; companionship), depending on needs and abilities. The home sharer would pay up to 30% of his or her income for rent. Providing services is not required to participate.
  - ii. ECHO Housing (Elder Cottage Housing Opportunity) or granny-flat as some might know it by is a small, separate, manufactured residence for an older adult that is temporarily placed in the side or rear yard of a host family- related by blood or marriage. This arrangement provides privacy and dignity to both the older adult and the host family. When the ECHO cottage is no longer needed, it is relocated to the property of another host family. The older adult would pay 30% of his or her income.

- a. Jennifer Eckerson with the Adams County Housing Authority provided an update for the Homeless Diversion program, 2 CDBG and 1 Home for Good grants that have been approved. Funding information is not yet available and the announcement will be made as soon as the applications are made available to the public.
- b. Megan Shreve with SCCAP provided an update on the SCCAP Apartments project. Adams County Community Foundation awarded funding for drawings and SCCAP is currently working with developers on the final price. - c. Pete Ricker with Habitat for Humanity provided an update on completed home projects and the Blitz Build in September.
