1. Broadband

- a. Taskforce Meeting on March 22nd
 - i. Updates Ralph Serpe and Commissioner Marty Qually shared updates from the first Broadband Taskforce meeting in March. This taskforce will be an organic, collaborative effort used to inform the County (local government officials and its residents) on the ways in which we can best bring quality broadband access to the community.
 - ii. Regional Study Robin Fitzpatrick shared with the group that this taskforce plans to work together to pull resources to conduct a regional study to assess need for access and to collect the most accurate data to develop a coverage map to determine where we can begin our work.
