### Topics of discussion:

- 1. Clearfield County Area Agency on Aging ECHO Program Success
  - a. Julie Fenton, Director of Outreach, Education & Community Services presented information on the ECHO Program in Clearfield County and the successful placement of three ECHO Cottages. #### 2. Housing

- a. Adams ECHO Updates
  - i. @Home, Adams County Office for Aging and SCCAP are working with a family and tenant in Butler Township who applied and are interested in participating in the ECHO Program. We are moving forward with this family to verify use of their property and to choose a developer for the cottage.
- b. Converge Entreprises Biglerville Rd. Duplex Project
  - i. Chad Collie of Converge Enterprises joined the group to provide updates about the progress of this project. Construction will begin soon.
- c. SHARE Updates
  - SHARE Coordinator, Valery Adams announced success in finding a match for the SHARE Program. Agreement between tenants will be signed and tenants can begin living together soon.

### 3. Broadband

- a. Taskforce Updates
  - i. Taskforce last met on Monday May 17<sup>th</sup> to start discussion about identifying the best funding source for broadband implementation and to determine the best method of implementation. Media and internet services providers in the group will be working to provide a drafted proposal for a hybrid service to include fiber and wireless options. Other participants will work to network with local businesses and school districts to identify need.

## 4. Transportation

- a. Gettysburg Hanover Connector (GHC) Ridership
  - i. Call to Action: Share with us your suggestions on how we can increase ridership and ticket sales.
- b. Commuter Services of Pa
  - i. Will be meeting with the Housing Authority to give out free ride passes and lead a field trip from New Oxford to Hanover. This is an effort to raise awareness of the GHC and to practice riding.
- c. Signage and bus schedule for the GHC is lacking and it is difficult to get information about the GHC from the rabbittransit phone line. Commuter Services, rabbittransit, and Adams County Community Foundation will meet to address this issue.
